## **Overview**

Much of the State is under an advisory today. Eastern Cochise county has a blowing dust advisory until 5pm this evening expecting low visibility of up to a mile. A winter Weather warning remain in effect above 6000 feet and will remain until 11zm this evening. Snow accumulations are as follows for Coconino. Grand Canyon 3 to 5 INCHES, Jacob Lake 1 to 3 INCHES, North Rim 2 to 4 INCHES, Valle 2 to 4 INCHES. Maricopa, Gila, Yavapai, and Coconino County will remain under a flood warning until 11:15 am today. Both Yavapai and Gila counties will likely see mainly liquid precipitation through Tuesday, with approximately 1 to 2 inches of rainfall forecast. Creek and streams in Yavapai and Gila counties will likely be running high through Tuesday. A small stream flood advisory has been issued for Yavapai and gila counties. expect stream rises to continue through the morning hours with some low water crossings to become impassable. Navajo and Apache Counties remain under a Hazardous weather outlook until Tuesday at 5pm.

NW Districts has seen snow across the district above 5,000 ft. Some unofficial totals range from a dusting of snow to 12+ inches on Mingus Mountain. Crews remain out and in full force in Prescott Valley and Seligman. Seligman is also on Ash Fork Hill with motorist assist and tie-ups. Crews will also be proactively addressing potholes throughout the entire district.

Prescott Valley- SR 89 Mile Post (MP) 297 - 310 white roads. MP 319-351 wet black roads. MP 351 - 362 white roads,

SR 69- MP 296 - 286, white roads. MP 286 - 280, wet black roads

SR 89A- MP 318 - 333, wet black roads. MP 343 - 373, white roads. MP 349 - 343, black wet

roads. 89A Spur- wet roads.

Cordes Jct- Black wet roads on SR 69, 169 and I-17

Kingman- SR 66, near Peach Springs. White roads from 105 - 123. I-40 black wet roads from MP 0 to 72 1.

Seligman- I-40, MP 72 - 91. black wet roads.

Wickenburg- SR 89 Patches of heavy fog from 273 to 276 wet roads slight drizzle on and off. Crews are patrolling the area of 272 to 280 knocking rocks off the road.

Wikieup- black wet roads. Some flooding and rock falls along SR 96 and SR 97

#### **ADOT Northcentral District**

- 0900. Heavy snow fell down to around 4800 feet leaving area highways snowpacked overnight. With the passing of the storm, highway conditions are now improving. Most Interstates and secondary routes in the Flagstaff region are wet to slushy. Highways in the Payson Rim Country are still snowpacked as the storm makes its way to the east. Current challenges include:
- One employee was taken to the Emergency Room with an ankle injury overnight.
- I-40 EB on Ash Fork Hill there are several tractor trailers that are stuck which is slowing traffic at MP 150. Conditions are improving and these trucks will be out of the way shortly.
- I-17 NB at MP 309. A tractor trailer is disabled and blocking the entire highway on a steep grade. This should be cleared shortly.
- I-17 NB at MP 292.5. A swift water rescue is taking place in Dry Beaver Creek adjacent to the Interstate. The shoulder and right lane are closed for staging of rescue crews.
- SR 260 at MP 240. High water is within a foot of crossing over the highway. Equipment is staged in case a closure is needed.
- SR 89A normal rock fall and tree fall activity is occurring within Oak Creek Canyon.
- The power is out at Little Antelope Maintenance (I-17, Munds Park) and the generator is not supplying sufficient power to run the fuel pumps. Equipment Services is working on the issue. Crews are getting fuel in Flagstaff.

Crews will continue with storm clean-up this afternoon and tonight. Evaluation of pothole priorities will also take place this afternoon. Pothole repair will start as soon as possible.

Keams received 4" on 264 towards the Mesa. SR87 received 2" roads are black and wet at this time. Keams has shifted 1 truck to assist Ganado on 264 to Steamboat.

Chambers getting snow at this time on I40 but roads are black and wet. Chambers has shifted 2 trucks to assist Ganado on 191.

Holbrook rain and sleet on I40, 77, and 377 roads are black and wet at this time. Holbrook has shifted 1 truck to Ganado to assist.
